# Aspire for a Safer Mississauga

Across Canada and indeed around the world, community foundations have become one of the fastest growing philanthropic networks. This is due in part to the donorcentric approach of a community foundation. Our Foundation connects donors with programs and services making a real difference in Mississauga.

Last month, we received a wonderful letter from a recent grant recipient, Safe City Mississauga. We share this letter with you and thank the Pendle Fund donor for creating the Fund at the Foundation that made this grant possible! Once you have had a chance to read this wonderful letter, we hope you are inspired to call our Foundation to create your own fund.

"My name is Sheena Moya Chen, and I'm the Program Coordinator for Safe City Mississauga's Aspire program, to which the Community Foundation of Mississauga generously awarded a grant of \$10,000 this year. I would like to take some time to update you on how the program is progressing and re-iterate just how grateful we are to have had the opportunity to apply for, and receive, this grant.

Since receiving the grant, we have opened an additional location in the Hurontario and Dundas neighbourhood, and we are in the process of opening a third at Britannia and Glen Erin soon. Because of the support you have given us, we have been able to provide the children and families

with a quality service positively affecting the community.

This August, we were able to take our students on another learning journey to the Ontario Science Centre, where they were able to view exhibits that sparked their interest, participate in activities inspiring a passion to learn, and eat and socialize with their tutors/ peer mentors, bonding in preparation for another academic year. We brought families together, bringing along with us 56 children, 12 parent volunteers and 17 tutor/peer mentor youth. One parent exclaimed "... that this trip made the summer" for her three children involved in the program who never got to go on any "outstanding" trips all

summer. We got to bring communities together as well, as the children, youth volunteers and families came from two different neighbourhoods.

I would also like to share with you some great news about an award we won for the Aspire program. The International Society of Crime Prevention Practitioners (ISCPP) hands out awards for various crime prevention based programs internationally, and we received the 2012 award for Community Based Crime Prevention Program of the Year! It is because of support like yours that we are able to continue to provide this service to the children that need it most. THANK YOU!

In Canada, these volunteers are responsible for ensuring that the organization achieves its goals, complies with applicable law and operates in a fiscally prudent and efficient manner. That the Foundation has achieved significant growth and impact is due to the remarkable individuals, people of outstanding skill and commitment, who have served the organization so well.

The By-laws of the Foundation task the organization to renew and build on its base of community champions and as such, the Directors have a limit on the number of terms they may serve. In December, we will see four Directors retire from the Board after they served all terms; Steven Offer, Tom Cooney, Paula Deering and Peter Campbell. An additional Director is also resigning to enjoy his well-deserved retirement, Gary Reamey. If we said the words "thank-you" a thousand times over, it would still not be enough to acknowledge the selfless service of these extraordinary volunteers. While it is not possible to list all of the progress that occurred under their stewardship, along with their Board peers they have achieved two Strategic Plans, built the endowments such that the Foundation has provided over \$3.3 million in grants, implemented a full suite of governance policies, created the Foundation's Tenth Anniversary Celebration and first Vital Signs publication. The Foundation is delighted to be welcoming new Directors in January 2013 including Erica Teklits, Howard McIntyre and Bonnie Tigemeyer. With their help, we look forward to the next stage of growth and progress.

## A Closer Look at Housing

Our fourth Community Knowledge Forum was held on October 24th at the Eden Community Food Bank. This time, we put Mississauga's housing options in the spotlight, taking the cue from our Vital Signs report that this was a topic worth exploring in more detail.


We know that stable housing has a significant impact on our physical, emotional and social well being. Our report indicated that as the price of houses in Mississauga is steadily increasing, space in shelters and transitional housing is declining. Many working families are finding home ownership out of

reach and more people than ever rely on food banks and community kitchens to make ends meet

It was an interesting and informative morning. We were very fortunate to have a room full of experts at this session who generously shared their valuable insight and perspective. Representatives from the Region of Peel and City of Mississauga provided a snapshot of what is happening at the regional and municipal level to address the need in our city. Several front line advocates and service providers gave us insight into the challenges many families and individuals face when attempting

to find housing and settle into our community. We discussed how important safe and affordable housing options are throughout the stages of our lives. And we talked about ways of working together to create a city that has choices to make it welcoming and supportive for all.

## national philanthropy day

Parliament has approved a new bill that will make Canada the first country in the world to honour the work of charities, donors, volunteers, corporations and foundations by permanently recognizing November 15th as National Philanthropy Day. First celebrated in 1986, National Philanthropy Day is marked by countries around the world. As noted in Bill S-201 sponsored by Senator Terry Mercer "...philanthropy helps build strong communities and active civic participation by bringing people together to serve a common goal..." This day pays tribute to the ability of giving to
